We continue to replace water meter registers with 20-year units. This involves significant capital expense yet we remain determined to complete the effort within our existing budget. To date we have replaced over 175 meter registers. We would like to thank Ben Pacatte for his above and beyond efforts, which are saving our association thousands of dollars!
