This year I'm asking for every members help in petitioning the Lewis County Commissioners requesting they include our roads within PCC for repair/repaying in the 2017 project list.

During the past two years our roads have been placed on this list and twice they were removed for other projects deemed more important by the Commissioners. It should also be noted the PCC Board of Directors added streets for water line replacement in anticipation of Lewis County repaving our roads.

Members are required to maintain control of their pets at all times. Dogs can violate our rules and covenants by running loose, attacking other animals or persons, defecating without owner cleanup or due to prolonged barking. control your pets; remember that a repeat infraction can result in a \$100 fine and the involvement of the Sheriff.

Emergency Management

Over the past two years, the PCC office has been evolving the Emergency Management capabilities supporting our community. This past September we finished the installation and testing of our emergency generator. We now have the ability to continue to run our office in the event of a power loss. Additionally, our office facility is equipped to temporarily house our local members if and when that need arises. facility will maintain heating, hot water, refrigerator and microwave functions, and the charging of personal devices. WIFI is also available, but is dependent on Centurytel internet service being available.



Lake Holiday

Due to potential liability insurance claims, our carrier has asked us to post signage stating that our lake area is private and is only to be used by our members and their guests. We were also asked to notify the President of Bavarian Retreat, so that he can notify the lot owners in that community.

Few people knew that our big lake is actually known as Lake Holiday. We have therefore posted a new Lake Holiday sign at the arched entrance adjacent to the lake parking lot.

Maintaining a supply of power is important, but it is only one basic need in the event of an emergency. The PCC office currently has an inventory of sleeping cots, blankets, reflective vests, hardhats, clipboards, ice, water jugs, and emergency tools as well.

While PCC strives to provide an initial Emergency Management capability, you are strongly encouraged to maintain adequate supplies of medicines, dietary needs, medical supplies, etc. in order to meet your critical needs.

Emergency Management has been added as a regular agenda item to our Community Watch meetings, which are held at 10am on the last Saturday of every even month (except December). We encourage you to attend an upcoming meeting.

Year End Cleanup

As is often the case, some of our lots have accumulated a significant amount of tree branches and brush over the past year. We endured a lengthy burn ban during the summer, which makes even clean-up more difficult. Fortunately the ban is now lifted and there is still time to tidy up our lots before the freezing weather impacts us! Please dedicate some time to clear your lot of debris. Pre-pay Discount!

6 bi-monthly water billings at \$36 each = \$216 per year. Deducting the 5% discount lowers this amount to \$205.20. Simply pay this amount for each lot you own no later than March 25th in order to receive your discount. The entire payment is credited to your account and means that you may not receive water bills until the entire credit has been used up. This saves PCC money due to the reduced printing, supplies and postage expenses. Your meter will still be read and any billable usage will also be deducted from your credit Please contact the balance. office at (360) 569-2669 if you have any questions related to this payment option, which is designed to \$ave you money!
