Ordinary people doing extraordinary things! As I watch the outpouring of help to those that were affected by the recent landslide in Snohomish County I see ordinary people stepping up to help their neighbors in need.

During our March board meeting, the Pierce County Department of Emergency Management gave a short presentation asking Paradise Estates community members to participate in a program titled Pierce County Neighborhood Emergency Team or PC-NET. This program is designed to provide our community citizens with the skills, knowledge, and tools to respond in an effective manner to an emergency in our neighborhood. Like the landslide, when emergency response capabilities become overwhelmed, neighbors become the first responders in their communities. PC-NET provides the training using a team building approach to develop response teams ready to work in an organized manner to help those in need. Once trained, participants can volunteer as a light search team member, first aid station, or pet care to name a few; anyone can participate.

As I look at the surrounding area where the landslide occurred, we need to recognize the vulnerability to the many hazards in our own area. If we are ready to respond to a disaster of this magnitude, we'll be ready to respond to most any type of emergency.

In the coming weeks the Board of Directors plans to meet with the PC-NET coordinator to see what our community can do to participate. More information will be available during our annual meeting in June.
